

# THERAPEUTIC MASSAGE

## ASSOCIATE OF APPLIED SCIENCE

Quarter Credit Hours Required = 104

The Associate of Applied Science degree in Therapeutic Massage provides students with the physical and technical skills required by healthcare and personal service employers in a number of allied massage settings. These include rehabilitation clinics, fitness centers, medical offices, hospital departments, salons, and integrative medical centers like chiropractic offices and sports fitness establishments. This program also gives students the basic tools to consider self employment as a career choice. Students are instructed in and expected to perform a wide range of massage techniques ranging from relaxation skills and stress management to neuromuscular therapies.

As part of their course work, students will perform a minimum of 800 hours of lecture and 240 lab hours of supervised in-class bodywork, including 120 practicum hours taught in one-hour therapy sessions and conducted outside of class time. The total clock hours are a combination of the in-class and outside-class therapy sessions. Students will practice techniques learned in class on each other, while learning to perform a full body massage. Students will act as clients and therapists. This practice is required to improve and enhance the quality of bodywork. All sessions are supervised by a licensed therapist and held in the on-campus student clinic. A competency checklist is completed for every session and records are maintained by the program director.

Upon successful completion of this program, students should be able to

- demonstrate competence in delivering classical and contemporary massage techniques;
- identify the relationship of clinical massage techniques to physical therapy, sports medicine, and some nursing practices;
- recognize the medical and therapeutic value of clinical massage;
- explain the connection of muscle movement and body mechanics as they relate to total wellness;
- classify the usage of complimentary therapies like Shiatsu, Rolfing, Acupressure, and Aromatherapy;
- document strategies for successfully completing the major content areas of the national certification examination: NCBTMB (National Certification Board for Therapeutic Massage and Bodywork); and
- coordinate a successful job search.

**Note:** Virginia College's Therapeutic Massage program curriculum is designed to prepare students to take the National Exam in Therapeutic Massage and Bodywork and/or FSMTB Massage and Bodywork Licensing Examination (MBLEx). To be licensed as a massage therapist in South Carolina, a person must (1) be at least 18 years of age and have received a high school diploma or graduate equivalency diploma; (2) have completed a 500-hour course of supervised study at an approved school; and (3) have received a passing grade on an approved examination. (Section 40-30-110, South Carolina Code of Laws, 1976, as amended [the Massage/Bodywork Practice Act, Act 387 of the 1996 General Assembly]). Students who perform massage as a part of their curriculum (whether on or off the school premises) must wear a nametag identifying themselves as students and naming the school that enrolls them. Students cannot charge or accept tips and cannot advertise. Students may not practice massage for remuneration until they finish the program, pass the national certification exam, and receive licensure from LLR.
